Members will have an opportunity to get the latest information regarding FCC activities that affect their businesses and daily responsibilities. These include, for example, an update on the proposed use of the 413-457 MHz band for the Medical Device Radiocommunication Service, and LMCC Comments; the 900 MHz decision; the FCC's on-going Part 90 rulemaking and follow-on 2<sup>nd</sup> R&O and 2<sup>nd</sup> FNPRM (FCC 10-36); FCC and Transition Administrator activities in respect of 800 MHz re-banding; recent legislative and regulatory developments affecting manufacturers' spectrum interests including Spectrum Inventory legislation; and meetings with policy-makers regarding manufacturers' important uses and needs for private B/ILT spectrum.

The MRFAC meeting **Registration Fee for each Member Representative and visitor is \$150.00 payable in advance or at the meeting** by credit card, cash, or check. The Registration Fee will be waived for invited guest speakers and for one representative from each prospective member company attending their first meeting.
